Notes Applicable to Table of Rates

- Carrier will accept the following Product grades at Oryx Crane Station, Crane, Texas: WTI, WTI Light and Condensate.
- The Committed Rates shall apply to Committed Shippers that executed a TSA with Carrier during the open season that commenced April 2019. A Committed Shipper shall be subject to the Committed Rate for any volumes shipped on the System during a month up to such Shipper’s Monthly Volume Commitment. A Committed Shipper shall be subject to the Uncommitted Rate for any volumes shipped on the System during a month that are in excess of such Committed Shipper’s Monthly Volume Commitment.
- The Uncommitted Rates shall apply to any Shipper that is not a Committed Shipper, and to any Barrels shipped by a Committed Shipper that are in excess of such Committed Shipper’s Monthly Volume Commitment.
- Carrier will accept the following Product grades at ODOT Midland Station, Midland, Texas: WTI, WTI Light and Condensate.

Rules and Regulations

For purposes of this F.E.R.C. No. 2.2.0 or subsequent reissues thereof, the following paragraph shall be added to the end of Item 7 (Prorationing Procedures) of Carrier’s rules and regulations tariff, F.E.R.C. No. 1.7.0 or subsequent reissues thereof:

- L. ***Shipper Obligations.*** Carrier will accept only good faith Nominations from a Shipper, and Carrier shall use whatever means reasonable to determine whether a

Nomination is made in good faith. Good faith means the ability and willingness of a Shipper to deliver to Carrier at the Origin Point(s) specified in the Nomination all the Barrels of Product set forth in such Nomination. As part of such determination, Carrier may require written assurances from a responsible officer of Shipper, through the submission of a notarized affidavit or similar document, confirming that Shipper's Nomination has been made in good faith. If, in its reasonable discretion, Carrier determines that all or any portion of a Shipper's Nomination is not made in good faith, Carrier shall have the right to reduce or reject, as applicable, Shipper's Nomination.
